

ORDER QUEUE MANAGER FOR DIAGNOSTIC IMAGING

Healthcare provider adoption of electronic health records has provided a timely and accurate way to submit electronic clinical requests for their patients' medications, lab tests and submit referrals to other providers.


Diagnostic imaging (DI) requests, however, continue to be sent via phone, fax, email, and paper printouts handed to patients. This manual handling prevails because DI staff must first:

- 1. Verify the request is correct and complete prior to scheduling
- 2. Review all necessary clinical details to support the reason for the procedure

If any information on the request is missing, or incorrect, the wrong procedure could be performed or the patient's procedure is delayed after they arrive. This results in costs to the DI provider from unnecessary use of equipment and a patient's lost time waiting for issues to be resolved.

- Centralize intake of electronic requisitions (HL7, FHIR, PDF or Fax)
- Enable unique workflows for procedure type
- Stop hunting for requisitions
- Reduce calls with ordering providers
- Improve care collaboration across providers

- Distributes reports to all carbon-copied providers to enable coordinated care
